## NOTICE OF PUBLIC HEARING ON THE PROPOSED RATES AND CHARGES OF THE TOWN OF KIRKLIN, INDIANA SEWAGE WORKS UTILITY

Property owners, ratepayers and other interested parties in or served or to be served by the sewage works of the Town of Kirklin, Indiana ("Town") are hereby notified that a public hearing will be held by the Town Council of the Town, at the Kirklin Town Hall, 113 N. Main Street, Kirklin, Indiana 46050, commencing at 7:00 p.m. on January 8, 2024. The purpose of the hearing is to consider an increase in the monthly sewage rates for the users of the Town sewage works. At the hearing, interested persons may be heard concerning the sewage rates and charges. The proposed ordinance, which was introduced by the Town Council at its meeting on December 11, 2023, will be effective after adoption and implemented as soon as practicable. The schedule of rates and charges is attached as Appendix A. The complete text of the proposed ordinance is available for examination and copying at the office of the Clerk-Treasurer at the Town Hall of the Town of Kirklin, 113 N. Main Street, Kirklin, Indiana 46050 during normal business hours and will be available at the public hearing.

Following the adoption of the ordinance, users located outside the Kirklin corporate boundaries may be entitled to petition the Indiana Utility Regulatory Commission under section IC 8-1.5-3-8.3 to review and adjust rates and charges imposed on the users if a petition under IC 8-1.5-3-8.2 or under IC 36-9-23-26.1 with respect to the ordinance has not been filed.

All other rates and charges of the Kirklin Sewage Works will remain unchanged.

On January 8, 2024, the Town Council shall consider, and may take action on, the proposed ordinance.
